Updated Timeline for UAD 3.6 Mandated Dates Are in Place

Appraisers may have a concern for the much anticipated new UAD form from Fannie Mae.



That is understandable, but not warranted for SFREP customers.

Developers at SFREP have been working diligently for more than two years to make sure you are ready on time, have the best format to complete reports, and are comfortable with the procedure. The timeline for the new UAD has not changed, but details have been added. The GSEs (Fannie Mae and Freddie Mac) have updated previously provided information with specific quarterly dates to help the industry develop more detailed plans for implementation activities.
